MAXIZO TRADING LLP POLICY ON SORM CERTIFIED PERSONELS

INTRODUCTION:

SEBI has notified vide its notification no. LAD-NRO/GN/2010-11/21/29390 published in the Gazette of India on December 10, 2010 regarding NISM-Series-VII: Securities Operations and Risk Management Certification Examination.

As per above notification, SEBI has given guidelines that persons associated with a registered stock-broker/trading member/clearing member who are involved in, or deal with, any of the below mentioned functions are required to have a valid NISM Series VII Certification:

- (a) Assets or funds of investors or clients,
- (b) Redressal of investor grievances,
- (c) Internal control or risk management, and
- (d) Activities having a bearing on operational risk,

As per above guidelines every staff of trading member is required to have NISM-Series-VII: Securities Operations and Risk Management Certification. In this regard NSE vide its circular NSE/INSP/27495 dated September 2, 2014 has given clarification that requirement of passing of NISM Series VII - Securities Operations and Risk Management Certification exam would be optional for associated persons handling the basic clerical/elementary functions in the above stated areas and whose work is supervised by NISM Series VII -Securities Operations and Risk Management Certification certified personnel. Further NSE has also made it mandatory for member to frame the policy on NISM-Series-VII certified personals to ensure that senior level personals should be well aware with operation risk involved in broking business. Accordingly, we are framing this policy.

I) <u>Personals who mandatory required valid NISM-Series-VII: Securities</u> <u>Operations and Risk Management Certification:</u>

- a) All personals having role of checker in account opening, Accounts, Back Office, and Depository operation.
- b) All Departmental head in KYC, Accounts, Back Office, RMS & Depository operations
- c) All personals in Surveillance and Risk management Department
- d) All Compliance team member who are assigned work to redress investor complaints except member given in point no. II
- e) Principal Officer
- f) All staff assign work of releasing data in Account, KYC, DP, Back office

II) <u>Personals who does not required valid NISM-Series-VII: Securities</u> <u>Operations and Risk Management Certification:</u>

- a) Personals who is inwarding of collateral's/cheques
- b) Persons performing maker entries
- c) Maker entry in the database
- d) Personals assigned work of photocopying, printouts, scanning of documents
- e) Personals assigned work of Preparing of MIS

- f) Personals who are sending of letters/reports to clients, Exchanges,
 SEBI, data entry, uploading on SCORES
- g) Personals who are attending calls, etc.
- h) Personals sitting on Reception
- i) Personals who is inwarding of complaints,
- j) Personals who is seeking documents from clients
- k) Personals who are Generating reports, Files in back and front office
- 1) Personals who are assisting dealer to give market quote to the clients
